Pavilion

The chairman gave a detailed 'behind the scenes' account of the various efforts between the Parish Council and the Ashburnham Estate for the removal of the travellers. An insurance claim has been submitted, it is unclear at the moment if likely fees by the bailiffs or the court order can also be claimed on the insurance. Cllr Keith Finch is to check the electrics to satisfy the parish council that they are safe, having been tampered with by the travellers and do any necessary repairs.

There is to be a working party at the ground to clear any remaining debris. Insurance

The occupation of the field by travellers has highlighted the need for users of the field to have their own insurance to cover loss and damage, as the council insurance only covers the pavilion building and the contents which it owns, fixtures, fittings, floor coverings etc.

BT Phone Boxes

Despite correspondence by the parish council voicing concern to their removal, no reply has been given, so it is assumed that they are to stay.

Village Hall

The parish council have received a reply from Strutt and Parker the answer they gave was that they would be happy to take back the village hall only if it was the wish of the villagers, they would develop it for housing, and would want to handle the whole project.

The chairman highlighted a request for RDC for donation of land as a temporary or permanent sight for the travellers, this meet with unanimous rejection by the parish council.

Ashburnham & Penhurst Parish Council

Unauthorised encampment on Ashburnham recreation ground and its subsequent effect on the financial situation of the Parish Council.

The Parish Council experienced an Unauthorised Encampment on its leased land between 25th April to 25th May 2005. An attempt to evict the travellers under common law was unsuccessful because the Police deemed the travellers caravans too large for the bailiff's tow trucks

The Parish Council's pavilion was used by the travellers without permission and electricity and water were stolen from the Council's supply.

Shortly after the travellers were evicted by the bailiffs it became apparent that the Parish Council was classified as a public authority. If it were then to apply to the County Court for an eviction order, it would have to provide evidence that it had taken into consideration the welfare needs and human rights of the unauthorised campers e.g children's schooling needs, health needs and housing or alternative site availability. (Clearly a ludicrous requirement for a small Parish Council.) Following legal advice, the Parish Council relinquished its lease of the land to allow the landlord's agents to apply to the County Court for an Eviction Order. (A private landowner would not have to consider the traveller's welfare needs) In the meantime the Police obtained an eviction order under the Criminal Justice and Public Order Act on the lead member of the travellers. This order was specific to the recreation ground so the travellers then moved into the next field to avoid complying with the order

The new site was also owned by the same landlord who then included the tenant farmer in the County Court action. The court action was successful and the travellers left for a new unauthorised campsite in Battle. At the same time the Police had obtained a separate eviction order to preclude the travellers from the whole Rother District. Both court orders are applicable for three months.

All Councillors will be aware that the costs incurred in evicting the travellers repairing the pavilion damage and cleaning up the site must be born by the Parish Council. It is also quite clear that the Council has no provision for these costs in this year's budget. The costs which are not reclaimable from our insurers must be born by the Council Tax payers of the Parish by way of an increase in the precept next year (2006). In the meantime the bills must be paid even before any money is forthcoming from the insurers.

It is my opinion that the Parish Council must raise a short term loan of £10,000 to allow it to pay its bills prior to raising monies via the precept next year, reclaiming VAT and receiving insurance payouts.

You will also see from the budget that the precept will have to be doubled from £6,000 to £12,000 next year to cover these costs.
