The meeting was adjourned to allow Councillors to be given a report by Paul Evans, Clive O'Sullivan and Richard White (members of the New Village Hall working group). A brief summary is as follows.

A. Why a new village hall:-

- a) Too costly to repair existing village hall and estimate of at least £17.000 has been quoted to restore it to its original condition. Any additions i.e. disabled toilets and an updated kitchen would be an extra expense.
- b) Regeneration:-It is felt by this committee that a new village hall would help to regenerate the village; examples of this have been seen in nearby Herstmonceux, Bodle Street, and Boreham Street.
- B) Proposals for new hall design and cost one estimate has been given in the region of £600,000

C) Development of old site

Nothing can be done whilst Mrs Hunt is living in her house, it is proposed to move the new village hall to the site of the sports pavilion, the old site would be handed back to the estate and the possibly houses built on the site, it is not clear at the moment how much revenue from this proposal would be made available to the village.

D) Future plans

To retain the existing village hall is out of the question.

The trustees of the Ashburnham Thanksgiving Trust would handle any new development at the old Village Hall site

The need to establish how much the ATT is willing to subsidise a new Village Hall needs to be settled before moving on.

A discussion then took place with members of the public who were present.

The Parish Council meeting then re-convened
